All of our solutions communicate using secure encryption technology via our data centers of the FastViewer Cloud. Choose whether you want to use the Cloud server worldwide, within Europe or exclusively the German Cloud server.

Alternatively, you can also operate your own FastViewer server.

The in-house server option can be integrated into your IT-infrastructure. It works independently of the FastViewer cloud server environment. We also offer a multi-tenant server which allows to run independent licenses for several customers on the same (ASP) server instance.

The FastViewer Modules – Anytime and everywhere

MODERATOR MODULE

With the moderator module you start the FastViewer session. Depending on the scope of your license, you can start a presentation or conference, conduct a spontaneous remote maintenance session or access a remote client. The moderator module can be used on any number of PCs with any number of users. You can customize the moderator module and the Sidebar to your Corporate Design in the customer portal.

CLIENT MODULE

The client module enables your session partners to participate in FastViewer sessions. It is free of charge and can be provided on your web server.

You and your customers can also [download](#) the client module from our website.

You can customize the client module to your Corporate Design in the customer portal.

MOBILE CLIENT

You can participate in a session with your mobile device such as iPhone, iPad or Android device. Just download the App from [Apples App-Store](#) or [Google-Play Store](#) for free.

WEB CLIENT

The web client (free of charge) enables you to participate in FastViewer sessions via any current web browser, regardless of the operating system. Join sessions without any installation.

You can see the screen and the webcam videos of your session partners and can communicate with them via chat and telephone conference.

REMOTE CLIENT

With the remote client, you can access unattended computers. This requires the remote client to be installed as a service on the relevant PCs. You can then access such PCs at any time via the moderator module.

This solution is ideal for accessing the server and for the remote maintenance of user PCs during and outside business hours.

PREPAID PACKAGE

The prepaid minute's package permits as many parallel sessions as required. The duration of use is charged at intervals of one minute (possibly per session). Active sessions are not interrupted even if the prepaid quota is used up.

You can check and refill your account by purchasing credits via the personal customer portal. Credits are activated immediately and you will then receive an invoice for the top up. The minute quota is valid indefinitely.

The prepaid version is also available as **All-in-One** solution.

SOFTWARE SUPPORT & MAINTENANCE SERVICE

¹ **Purchase:** The software support and maintenance contract is mandatory for the first year. The annually maintenance fee is 15% of the license list price. The main maturity of the contract is the 1st of the following month of the initial order.

License extension: The existing software support and maintenance contract increases to the next main maturity date and will be invoiced pro rata for the additionally purchased licenses, beginning 1st of the following month of the subsequent order.

Auto renewal for another 12 months period with a three months notice before the end of the contract.

You can download the contract from your personal customer portal.

² **Rental:** The minimum term of contract is 12 months. Auto renewal for another 12 months period with a three months notice before the end of the contract.

³ **Prepaid:** Minimum charging interval is 10 hours. The software support and maintenance services are included – no extra costs.
